4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

10. STABILITY AND REACTIVITY

Chemical stability: May react violently with strong acids. Carbon dioxide gas and large quantities of heat may be evolved.
