#### 4. FIRST AID MEASURES

### 5. FIRE FIGHTING MEASURES

Engineering measures: Natural ventilation should be adequate under normal use conditions. Keep containers closed when not in use.

Personal Protection Equipment: SAFETY SHOES, OVERALLS, GLOVES, SAFETY GLASSES.

Wear safety shoes, overalls, gloves, safety glasses. Available information suggests that gloves made from nitrile rubber should be suitable for intermittent contact.
